Councillor Head informed Members that she believes the East Riding of Yorkshire Council are inconsistent on their decisions.

Councillor Huntington informed Members that the East Riding of Yorkshire Council had recently changed their policies, including flood risk assessments, and this could be why the application had been refused and previous applications had been approved.
