

She stated that the position of the land, which is behind the TSB, is very difficult for traffic to access. The development could potentially lead to another 4 cars requiring access. She explained that the East Riding of Yorkshire Council (ERYC) has previously been asked to use the site for disabled car parking railway users.

Councillor D Jeffreys reiterated that it is a very poor road with lots of traffic and this development could prove dangerous.

Councillor Moore informed Members that this application has previously been opposed.

Due to overdevelopment of the site which has poor road access it was **RESOLVED** to object to the application.


