Councillor Moore referred to Planning application 03253 by The Green Team and a subsequent site visit during which demonstrated that the proposals would not have a detrimental impact on the café as suggested. He explained that confusion had arisen by Members having regard to a schematic drawing from The Green Team's business plan presented to the Council on 28<sup>th</sup> February, 2019 rather than the plans submitted to the East Riding of Yorkshire Council with the planning application.

Councillor Head re-iterated her previous comments regarding the impact on the café and the approach to the toilets.

She hopes that she can continue on the Board. She said that she and The Town Clerk had commenced the business planning process for the market and she wanted him to also have a place on the Board. She told Members that following any meetings they would be given regular updates. She also urged any organisations who qualify to apply for funding saying that the VPG will be applying and she hopes that the CCTV Group will put in bids to get a new system.

Councillor Head told Members that the four ward Councillors will be involved. She added that the matter needs sorting quickly and asked that she be allowed to stay on the Board.

Councillor B Jeffreys **PROPOSED** that Councillor Head be the nominated representative to The Town Deal Board.

Councillor Turner stated that all Councillors have their own ideas for different projects.

Councillor Walker asked for clarification on whether the Nominee has to be a Councillor.

The Town Clerk informed Members that the Nominee does not have to be a Councillor.

## GTC2804 TO AUTHORISE THE COUNCIL TO SUBMIT A BID TO THE WINDFARM TRUST TO FUND A DICKENSIAN WEEKEND FOLLOWING THE CHRISTMAS LIGHTS SWITCH ON

Councillor Head informed Members that ER Councillor Ann Handley has been looking into this. Councillors B and D Jeffreys are also helping.

Councillor Handley told Members that she has met with the Fairground Guild who have lots of Victorian items. They are also providing log cabins at no cost to GTC, which they will assemble and take down.

Councillor Boatman asked which Fair would be coming.

Councillor Handley said the Fair is Eddy's Fairground. They have several olde worlde carousels. Raymond Eddy is looking forward to returning to Goole as in the past the fair always came here.

It was resolved that the press and public be excluded for the following item under the Public Bodies (Admission to Meetings Act) 1960 in that it contains commercial or personal information as defined under the Local Government Act 1972 Schedule 12A the divulgence of which may be detrimental to the Council.

### GTC2805 TO RECEIVE AND ENDORSE THE RECOMMENDATIONS OF THE H.R. SUB-COMMITTEE IN RESPECT OF A REGRADING APPEAL

Members were in receipt of the above report.

Councillor Head informed Members that following discussion with Officers, there is a good case for regrading this position. The recommendation is to upgrade the post by 1 grade. The postholder is currently embarking on the NEBOSH General Certificate which is invaluable. This is expected to be completed in March, 2020. Following the successful completion of this it is recommended that the post be regraded by 1 further grade.

Councillor Moore asked whether the postholder could appeal if he disagrees with the reommendations.

The Town Clerk informed Members that an appeal can be made.

Members voted unanimously to endorse the recommendations of the H.R. Sub-Committee.
