## GTC2857 TO RECEIVE BUDGET & PRECEPT PROPOSALS FOR 2021/22

Councillor Head thanked Councillor B Jeffreys for preparing the Independent Party Draft Statement.

She called upon Councillor Moore to present the Labour Party budget proposal.

Councillor Moore started by thanking all Council Staff for their hard work during this difficult time and in particular the RFO who gave up her time during the Christmas break to meet with Councillors to discuss budgets.

The Labour Party presented their budget proposing to adopt the recommendations of the RFO. This means an increase in the Precept of 1.35% and an increase in the Council Tax of 2.81% which would raise a precept of £994,500.

Councillor Head thanked Council Staff for working so well under such difficult circumstances. She also thanked the Labour Group for their support.

The Independent Group presented their budget. They also proposed to adopt the recommendations of the RFO.

Councillor Moore informed members that if the RFO is happy with the facilities charges, the Labour Group will support it and a separate Meeting may not be necessary.

The Town Clerk informed members that the fees and facilities charges will need to be ratified at a different meeting.

The RFO informed Members that the Facilities charges will be discussed at the next P&R meeting. Members will be sent a copy of her proposals.

In conclusion it was **RESOLVED** that both the Labour Group and Independent Groups budgets are the same. Members voted all in favour. The budget is adopted without opposition.
