GTC2875 UPDATE OF WARD COUNCILLORS B JEFFREYS AND D JEFFREYS

Councillor B Jeffreys informed members that she would summarise part of the Draft East Riding Local Plan Update. She said that the proposed housing settlement covers a 19 year period from 2020 to 2039. Due to the Rapid Inundation Zone which is part of the strategic flood risk assessment and planning, the housing allocations in Goole have been de-allocated with the exception of three areas for industrial use, the Capital Park site – Siemens and Croda and Britannia Way. The Beal site which comprises 800 homes, continues to completion. A further 50 houses adjacent to this site, along Rawcliffe Road, will be built.

In response to the Town of Goole being unable to provide it's full share of the housing development requirements, Howden will be committed to building 2140 homes to provide for the shortfall.

Councillors B and D Jeffreys have been involved in numerous meetings with the Strategic Flood Risk Assessment Team and have engaged with Planning and Environment Officers to voice their concerns as money is coming in to develop the Town Centre to attract potential footfall and residents however the development of our historic buildings and the building of new homes is being stopped.

Councillor B Jeffreys informed members that they have suggested many ways of redeveloping properties and ensuring new builds are flood protected. Some suggestions are that homes could be built on stilts, there could be a balcony on the first floor ensuring a place of safety and an escape route or built over garages.

Councillor D Jeffreys also addressed Members about the Rapid Inundation Zone and the de-allocation of houses. He said that Goole is going to end up with lots of empty buildings and the Council needs to fight back as there are lots of mitigating circumstances.

A discussion took place regarding flood defences. Councillor D Jeffreys informed Members that he has attended another meeting with Alan Menzies about the money being spent on flood defences.

Councillor Handley informed Members that a few millions from the Town Deal Fund have been set aside to work on flood defences in partnership with the Environment Agency.

Councillors discussed the idea that it would be very hypocritical to still allow HMO's when no more houses can be built.

Councillor B Jeffreys informed Members that they have spent many months trying to sort out the vacant properties in the Town Centre,

To summarise Councillor D Jeffreys stated that what is happening in other areas eg houses being built on stilts should be being considered for Goole.
