Councillor D Jeffreys informed Members that there have been 3 objections from residents mostly due to the height of the scoreboard which is 4 metres.

Councillor Handley informed Members that she is looking into this application. She has spoken to the Planning Officer and there are currently four objections. She said that Goole Town Council can call it into planning. Residents are very upset about the sun glare which would need further investigation. They cannot object on the loss of view.

Councillor Raspin gave some background to the case stating that a Cricket Club Member passed away and left some money to the club. This paid for the scoreboard. The Committee however are unhappy as they didn't want the board. He added that if the scoreboard were to be relocated to the opposite corner there wouldn't be an issue.

Councillor Handley is meeting with residents as there are some other issues regarding trees, this issue can be addressed then. Following that meeting, it was agreed that this can be called into planning due to loss of amenity for residents.
