**GTC2988**      **EAST RIDING OFFICER'S TO UPDATE MEMBERS ON THE TOWN DEAL PROGRAMME AND THE LAUNCH OF THE PROPERTY ACTIVATION FUND**

Helen Houlton, Goole Town Deal programme manager presented updated information confirming Councillor B. Jeffreys as the Council's Towns Deals Representative. The Goole Town Deal was awarded in November 2019 as part of the levelling up fund

£25 million was awarded to be spent by 2026 and 10 projects approved for funding including the refurbishment of the Victoria Pleasure Grounds



Andrew Hewitt, Goole Town Deal property activation fund manager presented up dated information on inward and outward investments.  
Property Activation Fund encourages refurbishment of the Town Centre.  
A sum of £4 million is available and the fund opened for applicants on the 5<sup>th</sup> July 2023 and to date 27 applications have been received. The fund will match up to 50% of the proposed projects. The application process is in two stages and available funding is capped at £20,000. Councillor Marshall raised an issue of rubbish in Stanhope Street. This issue is already under consideration. Councillor Cooper questioned what can be done to attract national companies to the area. Councillor Jeffreys highlighted information on 8 local projects which is available on the Town Deal website.  
It was pointed out that the East Riding has an inward investment team that can offer help and advice to prospective companies.
