PR2276 REPORT OF THE OPERATIONS MANAGER AMENITIES – REPORT FROM THE AMENITIES WORKING PARTY

Members were in receipt of the above report.

SOUTH PARK - PARKING ISSUES

The report highlighted a number of complaints regarding cars parked down South Park Road and blocking access to H Waltons Ltd. The working party recommended increasing the overflow car park by 12 spaces. The estimated cost of £15,000 would be met by a £10k application to the Wind Farm Fund plus £5k from the West Park Heritage Lottery reserve fund.

It was **PROPOSED** by Councillor Bottomley and

SECONDED by Councillor Bailey that the recommendations of the amenities working party be APPROVED.

It was RESOLVED to APPROVE the recommendation of the Amenities Working Party

BOWLING GREEN - COLLECTION OF FEES

The working party recommended refusal of a request from bowlers to retain 10% of income collected due to the activity being already subsidised.

It was PROPOSED by Councillor Bailey and

SECONDED by Councillor B Jeffreys that the recommendation of the Amenities Working Party be **APPROVED**.

It was RESOLVED to APPROVE the recommendation of the Amenities Working Party

WEST PARK – DOG EXERCISE COMPOUND

Councillor Raspin had proposed the idea of a fenced dog exercise area, which would be funded by the Council with a fee being charged for its use. The amenities working party recommended that the proposal be put out to public consultation to ascertain demand and potential income and expenditure.

It was PROPOSED by Councillor Bailey and

SECONDED by Councillor Penn that the recommendation of the amenities working party be APPROVED.

It was **RESOLVED** to **APPROVE** the recommendation of the Amenities Working party.

CEMETERY - COMPLAINTS ABOUT SQUIRRELS

Members had received a complaint regarding damage by squirrels to floral tributes in the cemetery. The complainant suggested that squirrels be neutered to alleviate the problem. Councillor B Jeffreys had undertaken research into the issue which showed that this was both impractical and ineffective. The working party recommended that the complainant be advised regarding the types of flowers unattractive to squirrels and deterrent sprays.

It was PROPOSED by Councillor Bailey and

SECONDED BY Councillor Penn that the recommendations of the working party be APPROVED.

It was RESOLVED that the recommendations of the Amenities working party be APPROVED.

BRITISH SIGN LANGUAGE ADDITIONAL SIGNS

It was reported that Friends of West Park had been successful in their bid to the Wind Farm to install additional British Sign Language signs in the town. Councillor Flynn had suggested inviting the lady who first requested the signs to the next Friends of West Park meeting in order to compile a list of potential sites for approval. The working party recommended no further action at this time.
