

DEVOLUTION

Councillor Handley outlined the Devolution process and pointed out that we are the only part of Yorkshire without a combined authority.

There is an 8 week consultation process which closes on 27th February 2024 and she encouraged everyone to have their say.

She outlined the potential benefits in respect of the building of more affordable housing, the electrification of the railway between Hull and Sheffield and Hull and Leeds, £400 million investment funding over 30 years to deliver local priorities and the devolution of the core adult education budget. She added that government funding will also be made available to establish the new combined authority.
