

- All staff have been re-located either to Goole college pop up gym or surrounding areas where classes are been held temporarily
- Buses to North Axholme (looking to reduce from a 53 seater)
- No redundancies
- College is struggling with parking
- Swimming at North Axholme has increased
- Retained more members then expected at the college/gym
